

Frequently Asked Questions Regarding Form 1098-T

What is IRS Form 1098-T?

It is an informational form filed with the Internal Revenue Service to report the amounts billed to you for qualified tuition, related expenses, and other related information. The primary purpose of the IRS Form 1098-T is to inform you that we have provided this required information to the IRS

Why did I receive a Form 1098-T?

You may be able to take either the tuition and fees deduction or claim an education credit on Form 1040 or 1040A for the qualified tuition and related expenses that were actually paid during the calendar year.

What am I supposed to do with the Form 1098-T?

Unfortunately, we cannot provide you with tax advice, so we suggest that you contact your accountant or tax advisor if you have specific questions related to your tax requirements and responsibilities. However, we can inform you that you are not required to attach IRS Form 1098-T to your tax return, but it would be wise to keep it for your records.

How do I get a copy of my 1098-T?

Follow these instructions to view and print your form electronically.

- 1. Log in to YES*
- 2. Click on Student Accounts*
- 3. Click on View 1098-T Forms*
- 4. Select Appropriate Tax Year*

Can I get a copy of a previous year's 1098-T?

Yes, provided that a form was generated and issued to you for the year requested. Please follow the instructions above, being sure to select the appropriate tax year for your request. Why does this form not match the amounts that I paid for tuition and fees?

Vanderbilt University reports qualified tuition, related expenses and other related information billed rather than the amounts actually paid, so there could be some discrepancy in the two amounts. Also, be aware that the amounts posted on the form are reported on a calendar year format and not an academic year.

Why wasn't the form mailed?

As part of the Student Account Agreement you consented to receive your form online in PDF format via your YES landing page. Any request for a paper form must be submitted to the Office of Student Accounts at 1-800-288-1144 or student.accounts@vanderbilt.edu.

Why didn't I receive a 1098-T?

There could be a number of reasons, but it could be due to one of the following:

- *Your qualified tuition and related expenses were covered entirely by scholarships and/or grants, or an arrangement between us and your employer or some government entity.*
- *You are not a US Resident (you are listed as an International (foreign) Student for tax purposes.*
- *You received no academic credit for calendar year*
- *Your tuition was billed in a different calendar year*

The personal information (name, address, TIN, SSN...) is incorrect. What should I do?

What does the amount in Box 2 represent?

This box shows the total amounts billed in 2014 for qualified tuition and related expenses less any reductions in charges made during 2014 that relate to those amounts billed during 2014 - Per Instructions for Student located on second page of IRS Form 1098-T.

What does the amount in Box 4 represent?

This box shows any adjustment made for a prior year for qualified tuition and related expenses that were reported on a prior year Form 1098-T. This amount may reduce any allowable education credit that you claimed for the prior year (may result in an increase in tax liability for the year of the refund) - Per Instructions for Student located on second page of IRS Form 1098-T.

What does the amount in Box 5 represent?

This box shows the total of all scholarships or grants administered and processed by the eligible educational institution. The amount of scholarships or grants for the calendar year (including those not reported by the institution) may reduce the amount of the education credit you claim for the year- Per Instructions for Student located on second page of IRS Form 1098-T.

What does the amount in Box 6 represent?

This box shows any adjustments to scholarships or grants for a prior year. This amount may affect the amount of any allowable tuition and fees deduction or education credit that you claimed for the prior year. You may have to file an amended income tax return (Form 1040X) for the prior year- Per Instructions for Student located on second page of IRS Form 1098-T.

Why is Box 7 checked?

This shows that the amount Box 2 includes amounts for an academic period beginning January-March 2014. See Pub. 970 for how to report these amounts- Per Instructions for Student located on second page of IRS Form 1098-T.

Why is Box 8 checked?

This shows that you are considered to be carrying at least one-half the normal full-time workload for your course of study at the reporting institution- Per Instructions for Student located on second page of IRS Form 1098-T.

Why is Box 9 checked?

This shows that you are considered to be enrolled in a program leading to a graduate degree, graduate-level certificate, or other recognized graduate-level educational credential- Per Instructions for Student located on second page of IRS Form 1098-T.
